Stunting (Full supervision at all levels)

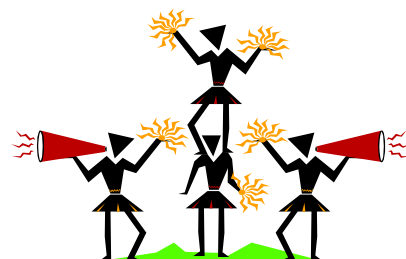
Tumbling (Full supervision at all levels)
